

### G&L 10 YEAR LIMITED WARRANTY

G&L Musical Instruments warrants to the original owner that this instrument is free from all defects in workmanship and materials for a period of **TEN (10) YEARS** from the date of purchase when purchased from an authorized G&L dealer.

This expressed warranty covers normal use and excludes the following:

1. Alterations or modifications to the instrument or repairs effected at a non-authorized service source.
2. Normal usage wear and tear (including: frets, tuning keys and plating) or damages from accessories (including straps and cords).
3. Damages to the finish for any reason such as exposure to extremes in humidity and/or temperatures.
4. The case, strings or battery.

Instruments must be returned by the original owner for repair under this warranty directly to G&L. Please call G&L service at **714-897-6766 extension 156** for return authorization. A copy of the original sales receipt must be provided for warranty service. All transportation charges will be the responsibility of the original purchaser.

G&L's sole responsibility in the event of loss by fire, theft or damage to the instrument while in the custody of G&L shall be limited to replacement with a new instrument of the same or most similar available model. Excess value and shipping insurance must be carried by the owner at his own expense.

All implied warranties, including but not limited to warranties of merchantability and fitness for purpose, expire upon the transfer of ownership of the instrument from the original owner or one year from date of purchase whichever occurs first. 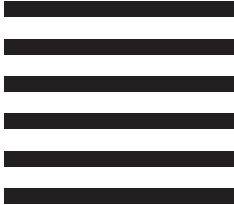
